I am writing further to your request made under the Freedom of Information Act 2000 received on 19 May 2023 (clarified response). NHS Cambridgeshire and Peterborough Integrated Care Board's (ICB) response is set out below:

Please set out how much money your integrated care board spent on hospice care for children and young people with life-limiting or life-threatening conditions between 1 April 2022 and 31 March 2023. Please provide a total, in addition to a breakdown of funding per children's hospice organisation.

I can confirm the ICB does not record or hold this level of detailed data.

3. Please set out how many children and young people with life-limiting or life-threatening conditions who live in your integrated care board footprint could benefit from children's hospice care.

I can confirm the ICB does do not record or hold this total dataset.

The ICB does hold data on numbers of Children and Young People (CYP) (0-18) with NHS CC needs with physical care needs – however this is only a portion of the CYP. For young people aged between 18 – 25 who may access adult hospices services we do not receive any datasets broken





down to the level requested. The individual adult hospices may potentially hold this detail. Namely, Arthur Rank Hospice, Thorpe Hall, Sue Ryder Care.

4. Please set out how much money your integrated care board plans to spend on hospice care for children and young people with life-limiting or life-threatening conditions between1 April 2023 and 31 March 2024. Please provide a total, in addition to a breakdown of funding per hospice organisation.
