Q3	<p>Your Question:</p> <p>Please set out how many children and young people with life-limiting or life-threatening conditions who live in your integrated care board footprint could benefit from children’s hospice care.</p> <p>Our Response:</p> <p><b>NHS Lancashire and South Cumbria ICB do not currently hold this information directly, as our children are held on many different clinical caseloads. However, a point prevalence audit was undertaken earlier this year for LSC, commissioned by NHSE (NW Coast Clinical Network) – cleansing of the data is underway at present. This will be shared with the ICB but we do not currently have the data.</b></p>
