Further to your request made to **Mid and South Essex Integrated Care Board** for information relating to the above and pursuant to the Freedom of Information Act 2000, please see the organisation's response below:

1. Please set out how much money your integrated care board spent on hospice care for children and young people with life-limiting or life-threatening conditions between 6 April 2022 and 5 April 2023. Please provide a total, in addition to a breakdown of funding per children's hospice organisation.

Please note figures below – these figures are for 1st April 2022 to 31st March 2023. Our contractual years start on 1st April and not 6th April.

- Little Havens: £614,244 (includes small contribution from West Essex and North East Essex but they form part of the MSE contract)
- EACH: £15,224
- 2. Please set out how many children and young people with life-limiting or life-threatening conditions who live in your integrated care board footprint accessed hospice care between 6 April 2022 and 5 April 2023. Please provide a total, in addition to a breakdown of funding per hospice organisation.
 - Little Havens: An average of 145 CYP supported each month.
 - EACH: An average of 9 CYP supported each month.
- 3. Please set out how many children and young people with life-limiting or life-threatening conditions who live in your integrated care board footprint could benefit from children's hospice care.

There is no definitive list of CYP with life-limiting or life-threatening conditions in Mid and South Essex, therefore unable to determine the number who can access. However, please note that any child or young person with a life-limiting or life-threatening condition who meets the criteria for Little Havens or EACH can access and benefit from the service.

4. Please set out how much money your integrated care board plans to spend on hospice care for children and young people with life-limiting or life-threatening conditions between 6 April 2022 and 5 April 2023. Please provide a total, in addition to a breakdown of funding per hospice organisation.

We believe you mean between 6 April **2023** and 5 April **2024**? If so, see answer below: Final figures for 1st April 2023 to 31st March 2024 are not yet finalised – awaiting confirmation of uplift figure before final amounts can be determined. Again, our contractual years run from 1st April each year and not the 6th April.

If you are dissatisfied with the response you have received, you have the right to request a review of our decision or make a complaint about how your request has been handled. Your request should be made within 40 working days of receipt of this letter, and we will reply within 20 working days of receipt. Any such request received after 40 working days will only be considered at the discretion of the organisation.
